UPDATE ON THE SHARE BUYBACK PROGRAM

Milan, August 12th 2024 – In relation to the share buyback program resolved by the Shareholders' Meeting of April 24th, 2024, Amplifon (EXM; Bloomberg/Reuters ticker: AMP:IM/AMPF.MI), the global leader in hearing solutions and services, announces that it has purchased in the period August 5th – 9th, 2024, a total of 200,000 ordinary Amplifon S.p.A. shares, equivalent to 0.088% of the share capital, at an average unit price of Euro 28.045 per share, for a total consideration of Euro 5,609,062.40.

On the basis of information provided by the intermediary agent appointed for the implementation, in full independence, of the share buy-back program, here below the details of the share purchase transactions on the MTA on daily basis:
