Rome, September 4th, 2024 – doValue S.p.A. informs that the report of the Board of Directors on proposals concerning item 5, on the agenda, extraordinary part, of the shareholders' meeting dated 11 September 2024 (the "**Explanatory Report**") has been re-published due to the correction of a material error on pages no. 5, 6 and 8.

In particular, the previous proposal to amend Article 15, paragraph 3, of the Articles of Association suggested deleting the sentence "and in the manner established by the Board of Directors", which should instead be maintained. For the sake of clarity, below is a comparison between the previously proposed text and the new text that will be included in the resolution proposal:
