UPDATE ON THE SHARE BUYBACK PROGRAM

Milan, September 16^{th} , 2024 – In relation to the share buyback program resolved by the Shareholders' Meeting on April 24^{th} , 2024, Amplifon (EXM; Bloomberg/Reuters ticker: AMP:IM/AMPF.MI), the global leader in hearing solutions and services, announces that it has purchased in the period September 10^{th} – 13^{th} , 2024, a total of 160,000 ordinary Amplifon S.p.A. shares, equivalent to 0.071% of the share capital, at an average unit price of Euro 27.477 per share, for a total consideration of Euro 4,396,257.52.

On the basis of information provided by the intermediary agent appointed for the implementation, in full independence, of the share buy-back program, here below the details of the share purchase transactions on the MTA on daily basis:

As of September 13th, 2024, Amplifon owned n. 884.799 of its shares, corresponding to 0.391% of the Company's share capital and to 0.275% of the total share capital in voting rights.
