MRS FERRETTI LEAVES THE CREATIVE DIRECTION OF THE ALBERTA FERRETTI BRAND

San Giovanni in Marignano, September 24, 2024. Alberta Ferretti, who will retain her role as Vice President of Aeffe S.p.A., will announce the name of the person chosen to succeed her as Creative Director of the Alberta Ferretti brand in the coming months.

Having taken note of Mrs. Ferretti's decision, Aeffe will proceed with a careful and in-depth analysis of the roles and functions of the various departments, with the aim of internally reorganizing its human resources in order to guarantee ever greater efficiency.
