### Periodic disclosure on the buyback program

Ronco Scrivia (GE, Italy), October 14<sup>th</sup>, 2024 - **Racing Force S.p.A.** (the “**Company**” or “**RFG**”), the parent company of Racing Force Group, which is specialized in the development, production, and marketing of safety components for motorsports worldwide, listed on the Euronext Growth segment in Milan (RFG) and Paris (ALRFG), with regards to the treasury buy-back program authorized by the Shareholders’ Meeting of April 29<sup>th</sup>, 2024, announces that between October 7<sup>th</sup> and 11<sup>th</sup>, 2024, it acquired on the Euronext Growth Milan segment no. 5,165 RFG shares, equal to 0.0189% of the share capital, at an average price of Euro 4.17 per share for a total of Euro 21,516.36.

The purchases were made through the intermediary Equita SIM S.p.A., LEI code 815600E3E9BFBC8FAA85.

Details of the daily purchase transactions on the market are reported below.

Following the above stated purchases, RFG currently holds 31,725 treasury shares, equal to 0.1158% of the share capital.
