**Milan, October 17<sup>th</sup>, 2024** – Alkemy S.p.A. (“**Alkemy**” or the “**Company**”), a leading company in the business model evolution of large and medium-sized companies and listed on the Euronext STAR Milan segment of Borsa Italiana (ALK), announces that, on October 16<sup>th</sup>, 2024 Retex S.p.A. – Società benefit (“**Retex**”), has submitted a request for the identification of the Shareholders pursuant to articles 83-*duodecies*, paragraph 3 of Legislative Decree n. 58/1998 (“**TUF**”) and 18 of the Company Articles of Association. At the date of the request, Retex held 49.65% of the total share capital of Alkemy.

Please note that following the so-called *settlement* – which occurred today – of the voluntary public purchase offer for all ordinary shares issued by Alkemy pursuant to Articles 102 and 106, paragraph 4, TUF, promoted by Retex (the “**Offer**”), subsequent to the reopening of the terms of the Offer pursuant to Article 40-bis, paragraph 1, letter a), of Regulation no. 11971/99, Retex holds a total of 56.61% of the Alkemy share capital.
