PLANETEL: NOTIFICATION OF PURCHASE OF TREASURY SHARES BETWEEN 21 OCTOBER 2024 AND 25 OCTOBER 2024

Treviolo (Bergamo), 25 October 2024 – Planetel S.p.A., ("**the Company**" or "**Planetel**"), the parent company of the group of the same name operating nationwide in the telecommunications sector, listed on the Euronext Growth Milan multilateral trading system organised and run by Borsa Italiana S.p.A., announces, in compliance with articles 2357 *et seq.* of the Italian Civil Code, art. 5 of the MAR Regulation, art. 132 of the Italian Consolidation Law on Finance and art. 144-*bis* of the Listing Rules and in the context of the share buy-back and disposal programme approved by the General Meeting on 29 April 2024, launched on 10 June 2024, that in the period between 21 October 2024 and 25 October 2024 inclusive it purchased on the Euronext Growth Milan market managed by Borsa Italiana S.p.A. a total number of 2,250 of its own shares (corresponding to 0.033% of the total number of shares which make up the share capital) at an average weighted unit price of 4.49 Euros, giving a total value of 10,105.00 Euros.

On the basis of the information provided by the intermediary appointed to make the purchases, MIT SIM S.p.A., the following is a summary of the transactions for the purchase of Planetel ordinary shares performed by the said intermediary during the aforesaid period, in aggregate form and day by day.
