Periodic disclosure on the buyback program

Ronco Scrivia (GE, Italy), October 28th, 2024 - **Racing Force S.p.A.** (the “**Company**” or “**RFG**”), the parent company of Racing Force Group, which is specialized in the development, production, and marketing of safety components for motorsports worldwide, listed on the Euronext Growth segment in Milan (RFG) and Paris (ALRFG), with regards to the treasury buy-back program authorized by the Shareholders’ Meeting of April 29th, 2024, announces that between October 21st and 25th, 2024, it acquired on the Euronext Growth Milan segment no. 4,570 RFG shares, equal to 0.0167% of the share capital, at an average price of Euro 4.13 per share for a total of Euro 18,890.59.

The purchases were made through the intermediary Equita SIM S.p.A., LEI code 815600E3E9BFBC8FAA85.

Following the above stated purchases, RFG currently holds 43,446 treasury shares, equal to 0.1586% of the share capital.
