## UPDATE ON THE SHARE BUYBACK PROGRAM

Milan, November  $4^{th}$ , 2024 – In relation to the share buyback program resolved by the Shareholders' Meeting on April  $24^{th}$ , 2024, Amplifon (EXM; Bloomberg/Reuters ticker: AMP:IM/AMPF.MI), the global leader in hearing solutions and services, announces that it has purchased in the period October  $30^{th}$  – November  $4^{th}$ , 2024, a total of I60,000 ordinary Amplifon S.p.A. shares, equivalent to 0.071% of the share capital, at an average unit price of Euro 25.704 per share, for a total consideration of Euro 4,II2,598.55.

On the basis of information provided by the intermediary agent appointed for the implementation, in full independence, of the share buy-back program, here below the details of the share purchase transactions on the MTA on daily basis:
