### SHARE BUY BACK

Reggio Emilia, 5 November 2024 – Newlat Food S.p.A. (the “Company” or “Newlat Food”) announces that, following the authorizations of the purchase and disposal of own shares by the Shareholders’ Meeting of 29 April 2024, in the period from 1 October to 31 October 2024, the Company bought back a total of 24,126 ordinary shares on the Mercato Telematico Azionario (equal to 0.05% of the share capital) at an average share price of € 11.58 and for a total value of € 278,633.26.
