Cesena, November 11st, 2024 – Trevi - Finanziaria Industriale S.p.A. (“**Trevifin**” or the “**Company**”) announces that today, Mr. Massimo Sala has resigned from the role of Chief Financial Officer, as well as from his duties as the manager in charge of preparing the company’s financial reports and the role of Investor Relations Officer, to pursue a new professional opportunity. The resignation will be effective as of January 11, 2025. Until that date, Mr. Sala will continue to perform his current duties to ensure necessary operational continuity and facilitate a smooth transition. As of today, Mr. Sala does not hold any shares in the Company. The Company expresses its gratitude to Mr. Sala for his significant professional contribution over the years. The Company has promptly initiated the selection process to identify a suitable successor and will announce the appointment upon its confirmation.

The Group was established in Cesena in 1957; it has around 65 companies and, with its dealers and distributors, is present in 90 countries. Internationalization, integration and the continuous exchange between its two divisions are among the reasons for the success of the Trevi Group: Trevi, which carries out special foundations and soil consolidation works for large infrastructure projects (subways, dams, ports and docks, bridges, railway and highway lines, industrial and civil buildings) and Soilmec, which designs, manufactures and markets machinery, systems and services for underground engineering.
