## **COMMUNICATION OF CHANGE IN SHARE CAPITAL**

**Arco (TN), November 14, 2024 –** Aquafil S.p.A., as an addendum to the communication to the markets dated December 5, 2022 concerning the 'Conversion of special shares into ordinary shares of Aquafil S.p.A.', reports the related T1 Form provided for capital transactions.

It is communicated the new composition of the share capital (fully subscribed and paid up) following the fulfilment of the provisions of Article 5 of the By-laws of Aquafil S.p.A, which provided for the automatic conversion of 100% of the category C shares (i.e. no. 80,000 category C shares) into ordinary shares, at a conversion ratio of no. 1 (one) ordinary share for each category C share, occurred on December 5, 2022.
