WIIT announces the renewal of a contract worth approximately EUR 2.6 million with a major Italian group specializing in system integration and application development at an international level

The agreements will last for five years and will cover Secure Cloud services both in the SAP domain and for applications developed by the Client

Milan, 18 November 2024 – WIIT S.p.A.
