EDIL SAN FELICE: NEW 12 MILLION EURO ORDER FROM ASPI FOR ORDINARY MAINTENANCE WORK**WITH THIS AWARD, THE AMOUNT OF TENDERS ACQUIRED DURING 2024 REACHES EUR 94.2 MILLION**

The works will be carried out on the section under the jurisdiction of the Cassino Section Management

Naples, 22 November 2024. Edil San Felice S.p.A. Società Benefit ('the Company' or 'Edil San Felice') - a leading integrated operator active in the maintenance of critical infrastructures in Italy, listed on the Euronext Growth Milan market - has been awarded the ordinary maintenance works on the 6th Section of the Cassino junction with a major contract from Autostrade per l'Italia worth € 12,079,468.57.

The framework agreement signed with ASPI, with a duration of two years from the stipulation and renewable for a further 24 months at the same economic conditions, provides for services and works relating to ordinary and recurring maintenance activities on the sections under the jurisdiction of the Cassino Section Directorate - Lot 16.

The order confirms and strengthens the company's position as a primary player in the motorway maintenance sector in Italy. In particular, ordinary maintenance is confirmed as a pivotal element of the company's strategy thanks to the recurring nature of the activities that provide immediate visibility on the company's results.

Edil San Felice will be in charge of ordinary and recurring maintenance activities on the motorway infrastructure and, more specifically, of works related to the maintenance of embankments, slopes, retaining walls, bridges, viaducts, overpasses, subways, tunnels and structures and plants functional to safety such as side and traffic barriers and noise barriers.

The works will affect the A1 Milan-Naples motorway on the Ceprano/Naples section, from km 733+690 to km 759+800, the A30 Caserta-Salerno motorway from km 0+000 to km 55+300, the A16 Naples-Canosa motorway on the Naples/Candela section from km 0+000 to km 127+627.

Lorenzo di Palma, CEO of Edil San Felice, commented: "This further contract confirms our role as a leading operator in motorway maintenance activities at national level, where we continue to strengthen our daily bond with the territories thanks to our construction sites. The awarding of two important contracts, in such a short timeframe, in both ordinary and extraordinary maintenance, is the result of the structural strengthening process that we have carried out in recent months and which is enabling us to seize market opportunities in the best possible way, even in a contextual manner".
