EDIL SAN FELICE: NEW ORDER FROM ANAS FOR A TOTAL VALUE OF 30 MILLION EURO FOR PLANNED MAINTENANCE WORKS

12.9 MILLION EURO FOR EDIL SAN FELICE

THE AMOUNT OF TENDERS ACQUIRED REACHES 107.1 MILLION EURO IN 2024

Naples, 27 December 2024 – Edil San Felice S.p.A. Società Benefit ('the Company' or 'Edil San Felice') - a leading integrated op-erator active in the maintenance of critical infrastructures in Italy, listed on the Euronext Growth Mi-lan market - has been awarded, a work order by ANAS with a total value of € 30,000,000.00, within the Temporary Consortium of Enterprises (RTI – Raggruppamento Temporaneo di Imprese) formed by Fenix Consorzio Stabile Scarl and Lgm Srl.

Edil San Felice, which was appointed as the consortium member for the execution of the works by Fenix Consorzio Stabile Scarl, was awarded an order worth 12.9 million euro.

The three-year framework agreement provides for scheduled maintenance works for the structural rehabilitation of motorway works and components in Campania in the sections under Anas' jurisdiction, in particular Lot 11 of DG/58/23.

Edil San Felice will undertake substantial works to restore the deteriorated parts of structures such as road and rail overpasses, tunnels and viaducts along the road network.

Thanks to this award, Edil San Felice's total tender acquired in 2024 amounts to EUR 107.1 million.

Lorenzo di Palma, CEO of Edil San Felice, commented: "With this award, we close 2024 with a value of EUR 107.1 million in orders acquired; this figure is definitely in line with our expectations, given the investments made to equip the company with an internal structure that allows us to take advantage of opportunities in several segments in the maintenance sector. The possibility of acquiring orders, both ordinary and extraordinary in road maintenance and, from this year, also railway maintenance all over the country, was exactly the goal we had set ourselves when we strengthened our managerial organisation. The direct consequence of this is the overall organic growth".
