El.En. spa: reacquisition of the qualification of "SME" pursuant to law

Florence, 8 January 2025 - El.En. spa, a leading company in the laser market, listed on the Euronext STAR Milan ("STAR") of the Italian Stock Exchange, hereby gives notice that, considering that art. 2 of Law no. 21 of 5 March 2024 changed the capitalization threshold for the qualification of SMEs from 500 million to 1 billion euros, Consob has updated the list of SMEs published on the website on 25 January 2024, by inserting the Issuer, on the basis of the new criterion calculated on the basis of the average capitalization during 2023, among the companies that qualify as SMEs as of the date of entry into force of the Capital Law (27 March 2024). Therefore, having not exceeded the raised market capitalization threshold for three consecutive years (2022, 2023, 2024), it qualifies as a small and medium-sized enterprise ("SME") pursuant to Article 1, paragraph 1, letter w_quarter.1 of Legislative Decree no. 58 of 24 February 1998 ("TUF").

Consequently, for the purposes of the disclosure obligations of significant shareholdings, pursuant to Article 120, paragraph 2, of the TUF, 5% of the capital is applied as the relevant threshold.

El.En., an Italian company, is the parent of a high-tech industrial group operating in the optoelectronics sector. Based on proprietary technology and multidisciplinary know-how, the El.En. Group manufactures laser sources (gas, semiconductor, solid-state and liquid) and innovative laser systems for medical and industrial applications. The El.En. Group is the laser market leader in Italy and among the top operators in Europe. It designs, manufactures and sells worldwide:

- Medical laser equipment used in dermatology, cosmetics, physiotherapy, dentistry and gynecology;
- Industrial laser systems for applications ranging from cutting, marking and welding metals, wood, plastic and glass to decorating leather and textiles and restoring/conserving artwork;

- Laser systems for scientific research
