BCC Iccrea Group and Accenture sign a partnership to support the Group's IT transformation. The agreement is part of BCC Sistemi Informatici's broader IT modernization plan.

ROME, January 23, 2025 - BCC Iccrea Group, the largest Italian cooperative banking group, and Accenture (NYSE: ACN) have signed a partnership agreement to support the Group's IT transformation as part of the broader technological renewal plan developed by BCC Sistemi Informatici.

This plan, which includes an investment program of over €300 million over the next three years, aims to accelerate the transformation process initiated with the establishment of the Group. The objective is to improve service levels for the 114 BCC member banks and other subsidiaries, offering members and customers services that are increasingly secure, efficient, innovative and user-friendly.

Specifically, the Group's new IT plan focuses on improving and modernizing the main core banking applications, further expanding the range of products and services available through digital channels and accelerating the implementation of its AI strategy.

In this context, the partnership agreement with Accenture, which also includes Accenture's acquisition of a stake in BCC Sistemi Informatici, focuses on digital platforms, core systems (including customer records and current accounts), and BCC's data platform. Additionally, Accenture will contribute to enhancing the infrastructure services provided to the Group's BCCs and developing a new service model designed to increase security and resilience levels.
