The Italian Sea Group, confirming its strategic positioning, has developed partnerships with important Italian luxury brands: Giorgio Armani, for the construction of yachts under his signature, expressing the fusion of two excellences of Italian style in fashion and boating, and Automobili Lamborghini, for the design and construction of the 'Tecnomar for Lamborghini 63', a limited edition motoryacht with extraordinary performance and quality beyond all limits.
