## UPDATE ON THE SHARE BUYBACK PROGRAM

Milan, March  $17^{th}$ , 2025 – In relation to the share buyback program resolved by the Shareholders' Meeting on April  $24^{th}$ , 2024, Amplifon (EXM; Bloomberg/Reuters ticker: AMP:IM/AMPF.MI), the global leader in hearing solutions and services, announces that it has purchased from March  $7^{th}$  to March  $14^{th}$ , 2025, a total of 240,000 ordinary Amplifon S.p.A. shares, equivalent to 0.106% of the share capital, at an average unit price of Euro 20.662 per share, for a total consideration of Euro 4,958,864.92.

On the basis of information provided by the intermediary agent appointed for the implementation, in full independence, of the share buy-back program, here below the details of the share purchase transactions on the MTA on daily basis:
