# Edil San Felice secures two new contracts from ASPI worth a total of 11 million euros for the maintenance and upgrading of safety barriers

**Naples, March 18, 2025.** Edil San Felice S.p.A. Società Benefit ("the Company" or "Edil San Felice") – a leading integrated operator in the field of critical infrastructure maintenance in Italy, listed on the Euronext Growth Milan market – has been awarded two new contracts from Autostrade per l'Italia. These contracts correspond to two separate lots under the same public tender (no. 69087) and have a total value of 11 million euros.

These two significant awards confirm the Company's leadership position in the highway maintenance sector, which remains a key element in Edil San Felice's development plan.

Both contracts involve routine maintenance and the refurbishment of highway safety barriers.

The first contract, worth 4,352,000 euros, pertains to Lot 4A, covering the areas managed by the Fourth Trunk Directorate in Florence.

The second contract was awarded in partnership with Tubosider S.p.A. as part of a Temporary Business Association, in which Edil San Felice holds a 77% share. This project concerns Lot 6B, covering the areas managed by the Sixth Trunk Directorate in Cassino, for a total amount of 8,742,000 euros, of which 6,731,340 euros are allocated to Edil San Felice.

**Lorenzo di Palma, CEO of Edil San Felice,** commented: "As part of the diversification strategy we are pursuing - one that has recently led us to enter two new markets, the railway and aerospace sectors - the highway maintenance sector continues to be a cornerstone of our development strategy. The deep expertise we have built over the years places us at the top of this sector, where we continue to see strong demand growth in line with the need for safe and reliable infrastructure for citizens. We are confident that our new organizational structure will allow us to seize the opportunities arising from our diversification strategy while maintaining our leadership position in our core markets."
