## NOTICE OF THE TOTAL AMOUNT OF VOTING RIGHTS PURSUANT TO ART. 85-BIS, PARAGRAPH 4-BIS, OF CONSOB REGULATION NO. 11971/1999.

**Rome, 4 April 2025.** Tinexta S.p.A. ("**Tinexta**" or the the "**Company**") announces, pursuant to Article 85-*bis*, paragraph 4-*bis* of the Issuers' Regulation adopted by Consob with resolution no. 11971 of 14 May 1999 (the "**Issuers' Regulation**"), the total amount of voting rights at the record date of the Shareholders' Meeting called for 14 April 2025, that is 3 April 2025.

The Company notes that there has been no change of the total amount of voting rights (increase or decrease) compared to what was communicated on 13 March 2025. The table below shows the data relating to the shares outstanding and the number of voting rights making up the share capital.

The Company holds 1.315.365 treasury shares, whose right to vote is suspended pursuant to article 2357-*ter*, paragraph 2, of the Italian Civil Code.
